

International Student Admission

Enrollment at Niigata University can be split into two main categories: Degree-seeking Students and Non Degree-seeking Students. The screening process for prospective students varies accordingly.

DEGREE-SEEKING STUDENTS

Degree-seeking Students are those who intend to obtain an undergraduate or a graduate degree.

Undergraduate Program

Normally a 4-year program (a 6-year program for the School of Medicine and the School of Dentistry) of study, resulting in the conferral of a Bachelor's degree upon acquisition of the prescribed number of credits.

The new semester begins in April. The classes and examinations at each of the departments at Niigata University are conducted in Japanese.

Applying for Special Selection as a Privately-funded International Student

Applications to Niigata University are accepted at the end of January every year, with selection taking place at the end of February. Applicants will be selected based on their results of the "Examination for Japanese University Admission for International Students" (EJU) and examination at Niigata University, and their TOEFL results depending on the program.

Other Application Processes

- Apply through general selection, as would a Japanese person
- Apply as an International Student funded by the Japanese Government (Recipient of a Japanese government (Ministry of Education, Culture, Sports, Science and Technology, "MEXT") scholarship)

Master's Program

Normally a 2-year program of study, resulting in the conferral of a Master's degree upon acquisition of the prescribed number of credits required for the relevant course, receipt of the required guidance, and success in final and thesis examinations.

The new semester begins in April or October. (Some faculties only accept enrollment in April.) Some courses are taught in English. Entrance exam contents vary by faculty.

Doctorate Program

Normally a 3-year program (a 4-year program for the Graduate School of Medical and Dental Sciences) of study, resulting in the conferral of a Doctorate upon acquisition of the prescribed number of credits required for the relevant course, receipt of the required guidance, and success in final and thesis examinations.

The new semester begins in April or October. (Some faculties only accept enrollment in April.) Some courses are taught in English. Entrance exam contents vary by faculty.

Professional Program

Niigata University provides two special programs ; Graduate School for Management of Technology (a 2-year program) and Law School (a 3-year program).

The new semester begins in April. The entrance examinations and most of the classes are conducted in Japanese.

NON DEGREE-SEEKING STUDENTS

Non Degree-seeking Students are those who attend classes or receive research supervision but who elect not to seek a degree. The new semester usually begins in April or October.

Auditing Students

Auditing Students are those who take undergraduate or graduate classes at Niigata University.

Application Requirements

Applicants must be high school graduates or equivalent.

With regard to application procedures, please contact the undergraduate or graduate office for more information about our programs.

Research Students

Research Students are those who conduct undergraduate or graduate research at Niigata University.

Many international applicants use this option during the preparatory phase for the graduate school entrance examinations.

Application Requirements

Undergraduate Research Students:	Those who have an undergraduate level degree or those who are deemed to have equivalent academic ability.
Graduate School Master's Program Research Students:	Those who have completed a graduate school Master's program or those who are deemed to have equivalent academic ability.
Graduate School Doctorate Program Research Students:	Those who have completed a graduate school Doctorate program or those who are deemed to have equivalent academic ability.

Special Auditing Students

Special Auditing Students are those who take undergraduate or graduate classes at Niigata University but who are enrolled at another university (international students from universities having exchange programs with Niigata University).

Special Auditing Students are accepted based on student international exchange arrangements between Niigata University and foreign universities (after discussion). Students interested in this application option should contact their current university's international exchange department.

Special Research Students (Graduate Level)

Special Research Students are those who conduct postgraduate research in a special field at Niigata University but who are enrolled in another university (international students from universities having exchange programs with Niigata University).

A Special Research Student is accepted based on student international exchange arrangements between Niigata University and the university where the student is enrolled (after discussion). Students interested in this application option should contact their current university's international exchange department.

Tuition and Fee Waivers for International Students
