## I. Admission Policy

# 1. Desired Student Profile

Graduate School of Medical and Dental Sciences (Doctoral Program in Health Sciences) aims to foster highly specialized professionals in the fields of Oral Health and Welfare, Nursing, and Next-Generation Medical Technology Science who can contribute to solving problems from both local and global perspectives.

We seek students who:

- Are deeply interested in healthcare and welfare issues and are motivated to solve problems using academic skills and flexible thinking.
- Possess teamwork and communication skills to collaborate across disciplines and professions.
- Are eager to contribute to both local and international communities.
- Are willing to continuously learn and adapt to rapidly evolving medical technologies.
- Aim to acquire advanced expertise and practical skills to lead problem-solving in healthcare and welfare fields.

## 2. Required Qualities and Abilities

- Basic Academic Knowledge: Equivalent to a master's level, including English proficiency.
- **Interdisciplinary Perspective**: Motivation to contribute to healthcare through exploratory and translational research.
- Problem-Solving Ability: Willingness to pursue original research topics.
- Communication Skills: Motivation to contribute to regional and global healthcare.
- Ethics and Social Contribution: Aspiration to become a leader in education, research, or advanced healthcare professions.

## 3. Basic Policy for Selection

Applicants are selected through three categories:

### 1. General Selection

All programs require an English language test and an oral examination.

- English Test: Evaluates reading and writing skills necessary for research and basic knowledge of the chosen field.
- Oral Examination: Assesses knowledge, problem-solving ability, communication skills, interdisciplinary perspective, and ethical awareness.

#### 2. Special Selection for Working Adults

Oral examination evaluates knowledge, problem-solving ability, language skills, interdisciplinary perspective, and ethical awareness.

# 3. Special Selection for International Students

Oral examination evaluates the same criteria as above.

- (1) Individuals who possess a master's degree or a professional degree (as defined in Article 104, Paragraph 1 of the School Education Act and Article 5-2 of the Degree Regulations [Ministry of Education Ordinance No. 9 of 1953]), or who are expected to obtain such a degree by March 2026.
- (2) Individuals who have been awarded a degree equivalent to a master's or professional degree in a foreign country, or who are expected to obtain such a degree by March 2026.
- (3) Individuals who have taken courses offered through correspondence education by a foreign institution while residing in Japan, and have been awarded a degree equivalent to a master's or professional degree, or who are expected to obtain such a degree by March 2026.
- (4) Individuals who have completed a graduate program at an educational institution located in Japan that is positioned within the educational system of a foreign country and designated separately by the Minister of Education, Culture, Sports, Science and Technology, and have been awarded a degree equivalent to a master's or professional degree, or who are expected to obtain such a degree by March 2026.
- (5) Individuals who have completed a program at the United Nations University (established based on the UN General Assembly resolution of December 11, 1972, as stipulated in Article 1, Paragraph 2 of the Special Measures Law [Law No. 72 of 1976] concerning the implementation of the agreement between the United Nations and Japan regarding the UNU headquarters), and have been awarded a degree equivalent to a master's degree, or who are expected to obtain such a degree by March 31, 2026.
- (6) Individuals who have graduated from a university and have engaged in research for at least two years at a university, research institute, or similar institution, and who are recognized by this graduate school as having academic ability equivalent to or higher than that of a master's degree holder based on their research achievements.
- (7) Individuals who, after completing a 16-year course of school education in a foreign country (or by taking correspondence courses offered by a foreign institution while residing in Japan), have engaged in research for at least two years at a university, research institute, or similar institution, and who are recognized by this graduate school as having academic ability equivalent to or higher than that of a master's degree holder based on their research achievements.
- (8) Individuals who are recognized by this graduate school, through an individual eligibility screening, as having academic ability equivalent to or higher than that of a master's or professional degree holder, and who will be at least 24 years old by March 31, 2026.
